## EVENING SPEAKER BIOGRAPHY

### James R. Kearl

Jim Kearl is the A. O. Smoot Professor of Economics and Senior Consultant with Charles River Associates. He has a PhD from MIT and did a post doc in law and economics at the Harvard Law School. He has taught economics at BYU since 1975. At BYU, in addition to his teaching, he has served as Dean of Honors and General Education, Associate Vice President and currently serves as the Assistant to the University President for the Jerusalem Center at Brigham Young University. In his consulting work, he has provided expert assistance to clients in over 80 intellectual property and antitrust matters in the U.S. and Europe. In 2012, he was appointed a Rule 706 expert for the Court in the Oracle v. Google patent and copyright matter. He and his wife Linda have 5 children (two of whom are graduates from BYU's accounting program) and 14 grandchildren. He has lots of hobbies, including cycling, cooking and collecting Islamic and tribal art.
